We are pleased to announce that our high school is offering a recurring off campus lunch privilege for students. This ongoing opportunity is designed to provide students with a break from the regular routine, allowing them to enjoy lunch in an outside the school building and fostering a sense of community. Furthermore, this academic incentive initiative aims to provide students with a change of scenery and encourage a sense of responsibility and independence.

Student Eligibility:

1. I will not engage in any inappropriate or dangerous behavior or activities outside the school premises during the designated lunch break. initial
2. If caught participating in any inappropriate or dangerous behavior or activities, I understand that I may lose my off campus lunch privileges indefinitely. initial
3. I will not bring outside food back into the school building. Any food or snacks purchased off campus must be consumed and finished off campus and outside the school building. initial
4. I am not permitted to deliver or buy food for another student inside the school during lunch. initial
5. I must return to the school premises before 1:15 pm to maintain my off campus lunch privileges. initial
6. I understand that I can only leave and return to the school building once during lunch. I cannot leave the school building again after returning from outdoor lunch. initial
7. I am required to have my physical student ID with me at all times when leaving the school building for off campus lunch. initial
8. I must be passing all classes to be eligible for off campus lunch privileges. initial
9. I must have no Disciplinary Actions recorded on the day of the off campus lunch to maintain my off campus lunch privileges. initial
10. I understand that the School may disallow me from leaving the school building, with or without advance notice, in the school's sole discretion for any reason, including but not limited to inclement weather, safety concerns, or educational or academic reasons such as on testing or assembly days. initial
